Minimum Eligibility Criteria:

Very high standard of workmanship and speed of construction is expected for these prestigious works. The firms who fulfil the following requirements shall be eligible to apply. Joint ventures are not accepted.

A The bidder should be in the business of civil construction works for a minimum period of five years as on 31/03/2023. The bidder has to submit the certificate of registration of the company/organization.

B The bidder should have minimum average annual financial turnover of Rs. 20.38 Crore for civil construction works during the last five financial year ending 31/03/2023(2018-2019,2019-2020,2020-2021,2021-2022,2022-2023) This should be duly audited by chartered accountant.

The value of turnover (by the bidders in the last 5 years) shall be brought to current turnover level by multiplying with following multipliers based on completion of financial year. (in Rs. Crores)

D The bidder should be a profit making (Profit before depreciation) organization for the last five financial years (2018-19, 2019-20, 2020-2021, 2021-2022 and 2022-23) Bidder has to submit the Audited P&L account, Balance sheet certified by chartered accountant along with ITR filed.

E The bidder should have solvency of 2.03 Crore bidders has to submit the certificate from the bank.

F Bidder/Tenderer/ Company/ firm who have been black listed/ debarred/removed from any organization/ agency or whose contract has been rescinded during the last five years or undergoing major litigation regarding debarring or rescinding of their work in any court of law will not be considered for qualification.
