1. Eligibility and Qualification requirements:

The bidders must meet the following minimum qualification criteria:

- 1. The Bidder in the same name and style should be in the similar business of Supply, installation, testing & commissioning of aseptic processing/packaging line for at least last four financial years ending March 2025. In case of change of name of bidder by merger/acquisition/ change in status, the bidder has to submit the documentary evidences.
- 2. The Bidder's average annual financial turnover in the same name and style for the three financial years (2021-22, 2022-23 and 2023-24) should not be less than INR 20 crores.
- 3. The Bidder in the same name and style shall have successfully executed/completed contracts of similar nature (Similar nature means bidder should have successfully supplied, installed and commissioned at least 02nos of aseptic milk/milk based products processing line and/or 02nos of milk/milk based products pouch filling machines, working satisfactorily within India.
- 4. The Bidder should have valid registration under various Acts that may be applicable for the contract proposed. This shall include but not limited to Income Tax, GST, Employee State Insurance, Contract Labour, Provident Fund etc.

Where the works are executed for private company the bidder/s, in support of their eligibility should submit the copy of the relevant TDS certificate received from their clients for the works.

Bidders shall submit the certified copy of the Annual report for the previous completed THREE years (audited balance sheet and profit & loss account) along with their PAN and Service tax/GST registration Number.

In the event of merger and acquisition causing change in the name of the bidder the copies of the balance sheets of the previous completed three years (audited balance sheet and profit & loss account) of earlier company whose business was transferred to the new company shall be furnished.
