### **A.SCOPE OF WORK.**

The scope of work is not limited to the specific work or some limited work. As per requirement of Item Description and demand by Civil Department, contractor has to start the work as per schedule given / programme given and complete it within time limit stipulated for that particular job.

### **B. GENERAL TERMS AND CONDITION.**

- a) The contracting firm should be registered with relevant authority and should be Income Tax paying.
- b) The contractor should have experience of minimum 5 years of industrial building & should have done similar work in any Institution/ Organisation for at least 2 years.
- c) The contracting firm should have minimum 25 no's of manpower in required category of Mason, Carpenter, Bar binder, labour, plumber etc.
- d) Contractor has to work as per instruction of Dairy's officials.
- e) Work carried out should be as per IS specifications and comply all requirement of Quality.
- f) Contractor shall keep the site neat and clean during his work, as this is food plant. Remove all debris at the end of day's work.
- g) Where ever, the item is only labour and material is in scope of Dairy, Contractor has to carry material from our stores/ yard of storage without any extra cost.
- h) In case of Item with material, contractor has to procure material of given specifications, and after procurement it should be checked and approved by Civil In charge of Dairy.
- i) The rejected material should be removed from site immediately.
- j) Contractor has to comply all statutory requirements, ESI, PF, etc.

### **C.SPECIAL TERMS AND CONDITION.**

- a) Contractor has to quote the rates for whole year starting from 01-04-2023 to 31-03-2025 Or two full year starting from the date of issue of the order, or it can be extended till the next year order is issued. The prizes shall be firm during the contract period.
- b) Contractor has to procure required material as per specifications/ instructed by I/C engineer.
- c) Contractor has to carry out work of any quantum, magnitude, small or big, under given job, without hesitation, refusal to this shall lead to termination of contract / penalty.
- d) Contractor is responsible to provide services for any time, any season during the contract
- k) Contractor has to furnish adequate manpower, as and when he is awarded any type of work, at any time, related to the Tender Item, refusal to it shall lead to termination of contract / Penalty for refusal.
- l) Work shall be allotted as per our requirement and our decision.

- m) Adequate safety measures shall be taken by the contractor for their personnel during the execution of the work. In case of any accident, No compensation shall be paid by dairy. There shall not be any liability of this nature to Banas dairy.
- n) Contractor has to take care of all require safety measures during execution of work. All the contractor's worker must have to wear all require PPE'S like helmet, safety shoes, safety belt, etc.
- o) Penalty shall be imposed in case of any work is found to be of sub standard
- p) The contractor has to abide the rules & regulations of Banas dairy. The worker should be free from any dieses and should not have any addiction of tobacco etc.
- a) Rates shall be inclusive of all applicable taxes, levies and any such loading imposed by government as and when.
- b) Contractor has to raise the bill after completion of the job in triplicate.
- c) Contractor's bill shall be checked by Engineer and payment shall be made within 15 days after certification of bill.
