Minimum Eligibility Criteria:

Very high standard of workmanship and speed of construction is expected for these prestigious works. The firms who fulfil the following requirements shall be eligible to apply. Joint ventures are not accepted.

**A** The bidder should be in the business of civil construction works for a minimum period of five years as on 31/03/2023. The bidder has to submit the certificate of registration of the company/organization.

**B** The bidder should have minimum average annual financial turnover of Rs. 12.17 Crore for civil construction works during the last five financial year ending 31/03/2023(2018-2019,2019-2020,2020-2021,2021-2022,2022-2023) This should be duly audited by chartered accountant.
