**3.0 Minimum Eligibility Criteria:** A very high standard of workmanship and speed of construction is expected for these prestigious works. The firms who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted:

<b>A.</b>	The bidder should be in the business of civil construction works for a minimum period of five years as on 31/10/2024.The bidder has to submit the certificate of registration of the company/ organization
<b>B</b>	The Bidder should have minimum average annual financial turnover of <b>Rs.4.60</b> Crore for civil construction works during the last five financial years ending 31/03/2024. (2019-20,2020-21,2021-22,2022-23,2023-24). This should be duly audited by chartered accountant. The Bidder must submit Annual financial reports with certified true copies of audited balance sheet with Profit & loss account statements and IT returns of said last five financial years for the proof of financial turnover along with PAN.
<b>C</b>	The bidder should have successfully completed similar works as under during the last 05 Years ending on 31/10/2024.  *3 (Three) similar completed works each costing not less than Rs.1.84 Crore. OR *2 (Two) similar completed works each costing not less than Rs.2.30 Crore. OR *1(One) similar completed works each costing not less than Rs.3.68Crore.

The value of executed work (by the bidders in the last 5 years) shall be brought to current costing level by multiplying with one of the multipliers based on the date of completion of project as given below (in Rs. Crore):

Note:\*Similar works means construction for Industrial/manufacturing/processing/Dairy projects/Hospital and/or Medical college/Residential staff colony/ Residential complex with different categories unit with multi-storied RCC framed structure, including architectural high finishes, services, internal/external water supply & sanitary installations, internal/external electrical works, cabling etc., Firefighting devices/ lifts/escalators, external development work including UG/OH water tank etc. Installation of security Gadgets and equipment etc. in case the bidder does not have the experience of major specialized works like plumbing, Electrical etc. such work shall be carried out by specialist agencies having sound financial background and experience of executing works for similar nature & magnitude. The bidder is required to give an undertaking.

**D** The bidders should be a profit-making organization for the last five financial years. (2019-20,2020-21,2021-22,2022-23 & 2023-24) Bidder has to submit the Audited P&L account, Balance sheet certified by chartered accountant along with ITR filed.

**E** The bidder should have solvency of 50 Lakhs Bidders has to submit the certificate from the bank.

**F** The bidder shall have Income-tax clearance certificate up to March 2024.

**G** Bidder/Tenderer/Company/Firm who have been black listed/debarred/removed from any organization/agency or whose contract has been rescinded during the last five years or undergoing major litigation regarding debarring or rescinding of their work in any court of law will not be considered for qualification. For that effect the bidder has to submit the notarized affidavit.
